The Same Company, Different Names

Over the last seven decades, the corporate name and underlying identity of the Company has evolved and changed. In this panel, we trace the history of ICI Pakistan Limited and its evolving identity.

1926: Imperial Chemical Industries (ICI) Limited formed

Imperial Chemical Industries (ICI) Limited formed in the United Kingdom following the merger of Nobel Industries Ltd, Brunner, Mond and Company Ltd, the United Alkali Company, and the British Dyestuffs Corporation.

ICI Limited establishes its first manufacturing site for the production of Soda Ash at Khewra in Pakistan. The Plant started commercial production as part of the Alkali and Chemical Corporation of India (ACCI) which was formed in 1937 to manage ICI's manufacturing entities in the sub-continent.
